## Executive Committee Meeting December 7, 2023

#### MINUTES

The Northeast Florida Regional Council's Executive Committee, pursuant to Chapter 120.525, F.S., held a hybrid meeting both in-person and virtually via Zoom, on Thursday, December 7, 2023 at 10:00 a.m.

**President Whitehurst** called the meeting to order with the following members present, representing a quorum:

#### **INVITATION TO SPEAK**

**President Whitehurst** stated that members of the public are welcome to speak on any item before the Board.

#### \*CONSENT AGENDA

**President Whitehurst** asked if anyone would like to pull any item on the consent agenda for discussion. **Commissioner Renninger** asked to pull City of Jacksonville Adopted Amendment 23-1ESR for discussion.

President Whitehurst called for a motion on the remaining consent agenda items. Commissioner Sullivan motioned to approve the consent agenda; seconded by Commissioner Renninger. Motion carried.

#### OTHER REPORTS/ACTION ITEMS

#### \*October 2023 Financial Report

Ms. Starling stated that the October 2023 financial report reflects a net income of \$9,014 and, as October is the beginning of the Council's fiscal year, the year-to-date net income is also \$9,014. The Members were informed that the audit will be presented in February 2024.

President Whitehurst called for a motion on the October 2023 Financial Report. Commissioner Martin moved approval of the October 2023 Financial Report; seconded by Mr. Register. Motion carried.

#### \*Website Design Services Negotiations

Ms. Payne stated that as a follow up to the November Board meeting, staff engaged in further discussions with the top two website design firms that submitted a proposal for the NEFRC's Request for Proposal (RFP) for website design – CONTROL+ ALT Digital and SGS Technologie. Ms. Payne provided an overview of the negotiations and recommended SGS Technologie for the Committee's consideration. Discussion followed.

President Whitehurst called for a motion to enter into a contract for Website Design Services. Mr. Register motioned to approve the selection of SGS Technologie to provide website design services for the Council and authorize staff to enter into a contract in the amount of \$40,000; seconded by Commissioner Renninger. Motion carried.

#### \*2<sup>nd</sup> Vice President Discussion

During discussion on the vacant 2<sup>nd</sup> Vice President position, Councilmember Ken Amaro was recommended. During discussions, it was requested that staff follow up with the Councilmember to determine if he is willing to serve in this role.

President Whitehurst called for a motion on the selection of the  $2^{nd}$  Vice President. Commissioner Martin motioned to approve Councilman Ken Amaro, if he is willing, as the  $2^{nd}$  Vice President of the NEFRC Board of Directors; seconded by Mr. Register. Motion carried.

#### Trails & Ecotourism Update

Mr. Anderson provided an overview of the activities of the Ecotourism & Trails Steering Committee and highlighted the Committee's project schedule to date. He also stated that in response to a support request letter from the NEFRC, the National Park Services' Rivers, Trails, and Conservation Assistance (NPS-RTCA) program staff visited northeast Florida to determine if assistance with resources and subject matter expertise could be provided in support of our regional trails and ecotourism initiative, as well as local partner projects. He also shared next steps that includes awaiting response from the NPS' synopsis and continuing to revisit the Council's workplan as there is more work to be completed in 2024. The next Steering Committee meeting is scheduled for December 18<sup>th</sup>. Discussion followed.

#### 2024 Workplan Discussion

Ms. Payne provided an overview of the Council's previous workplans, with ecotourism being the most recent. While staff has achieved much in this area, it is believed that there is much more to be done. With the NPS' visit and tour, the possibility of obtaining assistance from the federal level would be a boost to this effort and to our local governments. Therefore, staff recommends continuation of its work on ecotourism in the upcoming year. Discussion followed.

By consensus, the Committee requested that staff seek the support of the local legislative delegation for this effort via a letter, signed by the Board President.

#### \*Awards Selection

Sitting as the Awards Selection Committee for the Regional Leadership Awards, the Committee was presented with a summary of the 2023 nominations in each category, along with staff recommendations, for their consideration. Staff recommended Representative Cyndi Stevenson as the recipient of the 2023 Regional Leadership award. The winners will be honored at the Annual Elected Officials Luncheon and Awards Ceremony on January 4, 2024 following the Board Meeting.

President Whitehurst called for a motion on the 2023 Regional Awards winners. Mr. Register motioned to approve staff's recommendations; seconded by Commissioner Martin. Motion carried.

#### **Public Comment**

None.

#### **Local and Regional Discussions**

Clay County – Commissioner Renninger stated that he is the new Chair of the Board of County Commissioners.

Water Management District – Mr. Conkey introduced Mr. Bill White of the SJRWMD, the intergovernmental contact for Flagler, Putnam, Marion, and Alachua Counties. He also informed the Members that this is the time of year the District will be conducting controlled burns.

Flagler County – Commissioner Sullivan shared the County's problem with feral pigs in the eastern part of the County due to development. He also informed the Members of the County's representation on the NEFRC Board, which will consist of Himself, Commissioner Dance, and Mayor Alfin who will replace Mayor Robinson. Additionally, the County's upcoming Christmas Boat Parade now has over 100 boats participating. The Boat Parade is the largest in Florida and second largest in the US.

Nassau County – Commissioner Martin shared information on the upcoming Dickens on Center event in downtown Fernandina Beach to which everyone is invited.

**St. Johns County** – President Whitehurst mentioned the Night of Lights in St. Augustine, which draws nationwide and international visitors and also invited everyone to visit, but please pack your patience.

#### **CEO Report**

A new staff member was introduced: Mr. Andrew Prokopiak, Sr. Regional Resiliency Planner.

Possible Offsite Meeting: staff has been communicating with Mayor Alfin regarding inviting Speaker Renner to one of our meetings. If this is a possibility with his schedule following the Session, we may have the May or June meeting in Palm Coast with Speaker Renner as our guest. More information will be provided as we work on this. Discussion followed.

An update was provided on Council grants and contracts, i.e., City of Palatka Visioning, Town of Pomona Park comprehensive plan work, continuing the City of Jacksonville's special committee on Jacksonville Sherriff's Office facilities – Council staff will write the final report. Additionally,

staff is currently working on an application for Military Installation Resilience Review work; however, a match will be required. This item will be brought back for consideration.

#### Consent Item Pulled for Discussion

City of Jacksonville Adopted Amendment 23-1ESR – Mr. Jordan directed the Members attention to the COJ's adopted amendment and provided an overview of the amendment. He stated that there was only one change noted since the transmittal of the amendment, which was previously reviewed and approved. The change was a reduction in the amount of acres by 12.22 acres to remove all the land located in the accident potential zone two for the Naval Air Station. Due to the proximity to Clay County and the Town of Orange Park, staff recommended intergovernmental coordination between the City of Jacksonville and those jurisdictions. Both Clay County and the Town of Orange Park responded that the potential for a multiuse trail could be beneficial. Discussion followed.

Commissioner Renninger stated that his concern is, in the impact portion, it references Jacksonville International Airport (JIA), not Naval Air Station Jacksonville (NASJax) JIA has nothing to do with the content of the amendment. He also inquired if NASJax reviewed the amendment. Mr. Jordan stated that he was aware that NASJax did respond as a reviewing agency.

Further discussion revealed that the mention of JIA is likely a scrivener's error. Staff will provide the Members, via email, with confirmation of this and make the necessary corrections.

Mr. Register motioned to approve staff's review of the City of Jacksonville's adopted amendment 23-1ESR pending confirmation, and correction, of scrivener's error; seconded by Commissioner Renninger. Motion carried.

RE: LOCAL GOVERNMENT COMPREHENSIVE PLAN AMENDMENT REVIEWS

Pursuant to Section 163.3184, Florida Statutes, Council review of transmitted and adopted amendments to local government comprehensive plans is limited to adverse effects on regional resources and facilities identified in the Strategic Regional Policy Plan. The review is also limited to extra-jurisdictional impacts inconsistent with the comprehensive plan of any local government within the Region. Pursuant to Section 163.3184, Florida Statutes, a written report with an impact evaluation should be provided to the local government and the State land planning agency (Florida Commerce) within 30 calendar days of receipt (of the amendment).


A regional map of the listed amendments is provided on the next page, and the site-specific maps and policy text are provided in the appendix herein. Upon approval of this report by the Northeast Florida Regional Council (NEFRC) Executive Committee for transmittal to the State land planning agency, a copy will be provided to the respective local government.

#### Recommendation

Staff respectfully recommends that the NEFRC Executive Committee approve the staff review reports for the City of Bunnell Transmitted Ordinance 2024-06, Nassau County Transmitted CPA24-001, and Nassau County Transmitted CPA 24-002. Staff also respectfully recommends that the NEFRC Executive Committee concur that the City of Jacksonville Beach Adopted Amendment 23-1ESR is consistent with the Strategic Regional Policy Plan.

- Type: Text Amendment
- **Issue:** This amendment to the City of Jacksonville Beach Comprehensive Plan added a "Marina Mixed Use" Future Land Use Category to the City's Future Land Use Element.
- **Background:** To support the redevelopment of the City's only marina, including the reconstruction and realignment of Second Avenue North, the Planning and Development Department sponsored this Comprehensive Plan text amendment and related policies to the 2030 Comprehensive Plan to add a new future land use category entitled 'Marina Mixed-Use (MMA)'. The Marina Mixed-Use (MMU) Future Land Use category was created to support the marina's mix of water-dependent and water-related uses that complement the one public access marina that supports the residents and visitors of Jacksonville Beach and Duval County.

The Planning and Development Department proposed four new policies that have been added to the City's Future Land Use Element. These policies address the purpose of the new land use category, the general uses permitted in the land use category, the incorporation of residential uses, the location of the uses and impacts on natural habitats, and the provision of public access. The adopted policies are attached in Exhibit 1 within the Appendix for review.

Note: A public comment was received during the transmittal review, but the issue raised pertained to a local issue outside of our criteria.

- Impacts: There were no impacts to Resources of Regional Significance or extra-jurisdictional impacts that would be inconsistent with the Comprehensive Plan of an affected local government identified by Staff.
- **Recommended Intergovernmental Coordination:** Considering this is a text amendment to the City's Comprehensive Plan, no intergovernmental coordination is recommended by Staff.

- **Type:** Text Amendment
- Issue: This is an administrative request to amend the City's Comprehensive Plan to remove the "Conservation-One" Future Land Use designation held in various ownerships. The "Conservation-One" Future Land Use Map designations will be replaced with a future land use designation that matches the ones on the balance of the properties. The text of various policies within the Future Land Use and the Conservation Elements within the Comprehensive Plan is being amended to remove the "Conservation-One" Future Land Use designation from the Future Land Use element, rename the "Conservation-Two" as simply "Conservation", and to allow the City to rely on State and Federal wetland regulations procedures. This is Phase 3 "A" of a 3-phase effort to rezone properties to an appropriate Bunnell zoning classification.
- Background: The City of Bunnell annexed many thousands of acres of land into its corporate limits in 2006-2007. The City's Comprehensive Plan was amended to provide future land use designations for the annexed land. These new land use designations were a one-to-one translation from the Flagler County future land use designation already on a particular property to the closest City equivalent future land use category. The underlying Flagler County zoning was left in place. Up until Phase 1 of this rezoning effort, almost all the annexed lands still retained their obsolete Flagler County zoning. A few properties having no zoning at all are shown on the official zoning map as "ND- No Designation". This is a problem because land without any of the City of Bunnell Zoning categories is not covered by the City's land development code. At the same time, the City does not have the authority or jurisdiction to administer the County's land development code. This makes the remaining Flagler County zoning essentially a holding category, meaning that the property owners are forced to go through a full zoning change before they can obtain any building permits on the property. Many property owners have had planned projects significantly delayed because they had not anticipated the time and expense associated with this rezoning constraint.

To remedy this situation, the City of Bunnell has embarked on this 3-phase mass rezoning effort. The City's planning consultant was directed to assign the appropriate Bunnell zoning classifications to the corresponding properties based on the Future Land Use Map in the City of Bunnell's Comprehensive Plan 2035. This is in conformance with Florida law, which requires that all land development regulations that include the zoning map must be consistent with the City's most recently adopted comprehensive plan.

- Impacts: There were no impacts to Resources of Regional Significance or extra-jurisdictional impacts that would be inconsistent with the Comprehensive Plan of an affected local government identified by Staff.
- Recommended Intergovernmental Coordination: Considering this is a text amendment related to Flagler County's adopted Land Development Regulations, Staff is recommending for the City of Bunnell to continue ongoing intergovernmental coordination efforts with the County and inform the County about the City's recent changes to the Land Development Regulations upon its adoption.

- Type: Future Land Use Map
- **Issue:** This proposed amendment provides for the reclassification of approximately 248.75 acres of real property located on the south side of US Highway 90, adjacent to the Baker County Line, from the Agriculture (AGR) and Commercial (COM) Future Land Use categories to the Industrial (IND) Future Land Use category.
- Background: This proposed amendment to the County's Future Land Use Map (FLUM) in the Comprehensive Plan comprises of two parcels totaling approximately 248.75 acres located on the south side of US Highway 90, adjacent to the county line shared with Baker County. The property is currently zoned Open Rural (OR) and Commercial, General (CG) and has been utilized for timberland since 1996. There is also a companion rezoning application to change the zoning on the property to Industrial Warehouse (IW). The underlying Future Land Use on the subject property is Agriculture (AGR) and Commercial (COM). This amendment to the existing FLUM designation from AGR and COM to Industrial (IND) will create consistency between the proposed zoning district and land use category.

Land-designated Industrial (IND) on the Future Land Use Map (FLUM) is intended for activities that are predominantly associated with the manufacturing, assembly, processing, or storage of products and provides for a variety of intensities of use including heavy industry, light industry, and industrial park operations. This amendment would expand the existing IND FLUM designation to the south and form an 694.46-acre industrial park. Major transportation assets include access to US Route 90, proximity to Interstate10, and direct access to an existing CSX/SAL rail line. Currently, there is no development on the property. Please see Maps 1 and 2 in the Appendix for more information.

• Impacts: The subject property is located south of U.S. Route 90 and north of Interstate 10, these roads are considered to be two Resources of Regional Significance. The proposed project will be built out in three phases and access to the proposed development will be provided via several driveways and roadways on US Route 90/Beaver Street. Daily trip generation for the proposed development under each of the development phases was estimated using the rates and equations included in the Trip Generation Manual 11<sup>th</sup> Edition, published by the Institute of Transportation Engineers. The years 2027, 2030, and 2035 background conditions Annual Average Daily Traffic (AADT) were estimated by applying a growth factor to the year 2021 AADTs or using the year 2025, 2030, 2035, and 2040 AADT projections included in the Florida Department of Transportation D2 LOS Manual. The yearly growth rate was estimated by performing a trend analysis of the historical AADT. A minimum of 2.0% yearly growth rate was applied on roadway segments that showed a negative or less than 2.0% growth rate. All the study road segments are anticipated to operate under their adopted levels of services during the phase developments. A detailed operational analysis of all the project access intersections on Beaver Street/U.S. Highway 90 will be submitted to both the Florida Department of Transportation and Nassau County at the time of the Planned Unit Development (PUD) review submittal.

•	<b>Recommended Intergovernmental Coordination:</b> Given the proximity of the development to adjacent counties and jurisdictions, intergovernmental coordination is recommended with the City of Jacksonville, the Town of Baldwin, Baker County, and the City of Macclenny. During the transmittal phase, Nassau County staff reached out for contacts from these communities, and they were provided to Staff.

- Type: Site Specific Text Amendment
- **Issue:** This is an amendment to the County's Future Land Use Element Policy FL.11.08.D, which is a site-specific policy and a voluntary proffer to limit the maximum development on a property referred to as CPA09-002 ICI Villages LLC (Ordinance 2009-20). The property is about 487.19 acres lying in Sections 29, 30 and 31, Township 2S, Range 23 East located between U.S. Route 90 and Interstate 10.
- **Background:** Comprehensive Plan Policy FL.11.08.D was brought before the Board of County Commissioners for transmittal to state agencies on April 13, 2009 and was adopted on August 24, 2009. This policy was a voluntary proffer from the applicant to limit the maximum development program on the property to 487.19 acres to address concerns related to the provision of water, wastewater, and transportation infrastructure necessary to mitigate the impacts of the development on the site. As part of concurrency requirements at the time of the application, the applicant's proffer allowed the existing infrastructure to maintain the required level of service. The adopted policy limited the maximum potential development to 2.35 million square feet of industrial and 40,000 square feet of commercial.

With the current application CPA24-002, the applicant proposes a master site plan that meets traffic impact requirements and will bring in water and sewer through Duval County with JEA services. Regarding the conservation requirements, the 75 acres were reclassified as Conservation I (CSV I) and shall remain CSV I on the County's Future Land Use Map. According to Policy FL.04.01, a natural vegetative upland buffer shall be required and maintained between developed areas and contiguous wetlands to protect the water quality of the wetlands. This buffer shall be evaluated at the time of the site plan review.

The amendment will be required to be transmitted to state agencies, neighboring counties, and affected neighboring municipalities including the Town of Baldwin and the Town of Macclenny for further review. All findings from the transmittal will be presented to the Board of County Commissioners for consideration. Based on the submitted materials of this application, Staff finds there is sufficient infrastructural capacity and compliance with the current comprehensive plan policies to support the removal of FL.11.08.D. Please see Exhibit 2 in the Appendix for a copy of Policy FL.11.08 and the portion of text that is requested for removal from the County. A location map is also provided in the Appendix.

**Impacts:** The subject site is located south of U.S. Route 90 and north of Interstate 10, which are considered to be two Resources of Regional Significance. The proposed project will be built out in three phases and access to the development will be provided via several driveways and roadways on US Route 90/Beaver Street. Daily trip generation for the proposed development for each of the development phases was estimated using the rates and equations included in the Trip Generation Manual 11th Edition, published by the Institute of Transportation Engineers.

The years 2027, 2030, and 2035 background conditions AADT were estimated by applying a growth factor to the year 2021 AADTs or using the year 2025, 2030, 2035, and 2040 AADT projections included

in the FDOT D2 LOS Manual. The yearly growth rate was estimated by performing a trend analysis of historical AADT. A minimum of 2.0% yearly growth rate was applied on roadway segments that showed a negative or less than 2.0% growth rate. All the study road segments are anticipated to operate under their adopted levels of services during the phase developments. A detailed operational analysis of all the project access intersections on Beaver Street/U.S. Route 90 will be submitted by the developer to both the Florida Department of Transportation and Nassau County at the time of the Planned Unit Development (PUD) review submittal.

• Recommended Intergovernmental Coordination: Given the proximity of the development to adjacent counties and jurisdictions, intergovernmental coordination is recommended with the City of Jacksonville, the Town of Baldwin, Baker County, and the City of Macclenny. During the transmittal phase, Nassau County Staff reached out for contacts from these communities, and they were provided to Staff.

Exhibit 1: City of Jacksonville Beach 23-1ESR (Adopted Policies)

## Policy LU 1.5.15 MARINA MIXED-USE (MMU)

The Marina Mixed-Use land use category is intended to provide for a mix of water-dependent and water related uses that support the one public access marina that serves the residents of Duval County and is accessible in Jacksonville Beach.

The Marina Mixed-Use (MMU) land use category is created to provide an appropriate location for both recreational and commercial boat storage, water access, and water related commercial uses located on the Intracoastal Waterway. Uses allowed in the Marina Mixed-Use land use category include dry boat slips, wet boat slips, boat ramps, restaurants, offices, personal and business services, light manufacturing, water transportation retail sales, boat repair, storage/warehousing, ancillary marina uses, public and private parks, hotels, and townhouses and multiple-family residential and related accessory uses. This category permits supporting marina based commercial retail and services.

### Policy LU 1.5.16

Multi-family development may also be allowed within the Marina Mixed-Use land use category. Land development regulations shall include standards for minimum setbacks and buffer zones between different types of land uses allowed in this category, as well as locational criteria for such

uses. For MMU-designated parcels, residential densities of up to 15 units per acres are permissible.

### Policy LU 1.5.17

Expanded and new water-dependent and water-related mixed uses should be located in areas with the least impact on the natural habitat and wildlife and shall comply with Policy LU 1.4.11.

### Policy LU 1.5.18

Existing marinas should preserve a public access walkway and public access boat launch and public parking.

## Exhibit 2: Nassau County 24-2 (Changes to Future Land Use Element Policy 11.08)

#### Policy FL.11.08

Notwithstanding the entitlements provided under this Comprehensive Plan, certain property owners have voluntarily proffered, and Nassau County does hereby accept, an agreement to limit the development of their property in accordance with the adopted policies under this objective and subject to compliance with all applicable development standards and procedures.

Voluntary proffered agreements to limit development on specific property shall be approved by the County through the Comprehensive Plan amendment process and memorialized in an adopted policy that specifies the location and ownership of the property at the time of amendment adoption. The policy shall specify the maximum development program to be allowed on the subject property and any other limitations agreed upon with the county. Unless otherwise specified, the limitations shall remain on the subject property regardless of ownership or future subdivision of the property.

The location of the subject property of an approved voluntary proffered agreement shall be delineated on the Future Land Use Map (FLUM) and annotated with a description of the maximum development program for the property. This Policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(a-f).

A) CPA06-007 Corporate Realty Advisors (Ordinance 2008-09): Approximately 25 acres in Section 39, Township 2N, Range 26 East and Section 44, Township 2N, Range 27 East located in the northeast quadrant of the interchange of Interstate 95 and S.R. 200 lying north of the electric transmission line easement recorded in O.R. 123 at page 284. This property was the subject of CPA06-007 (Ordinance 2008-09) and is owned by Corporate Realty Advisors of Jacksonville Beach. Said parcel

is limited to 250,000 square feet of shopping center, ITE Code 820 or an equivalent commercial use, or combination of uses, generating no more than 982 new p.m. peak hour trips (total trips minus pass-by trips). This policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(a).

- B) CPA08-005 17/95 RV Park LLC (Ordinance 2008- 20): Approximately 149.88 acres lying in Section 35, Township 4N, Range 26 East and Section 02, Township 3N, Range 26 East located in the northwest quadrant of the interchange of Interstate 95 and U.S. Highway 17. This property was the subject of CPA08-005 (Ordinance 2008-20) and is owned by 17/95 RV Park LLC of Fernandina Beach. Said parcel is limited to 1,209,300 square feet of general light industrial, ITE Code 110 or an equivalent combination of industrial uses generating no more than 1,572 p.m. peak hour trips. This policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(b).
- C) CPA08-004 Harts Road LLC (Ordinance 2008-19): Approximately 200 acres lying in Section 42, Township 2N, Range 27 East located near the intersection of William Burgess Blvd. and Harts Road. This property was the subject of CPA08-004 (Ordinance 2008-19) and is owned by Harts Road LLC of Fernandina Beach. Said parcel is limited to 2,050,000 square feet of High Cube Warehouse, ITE Code 152 or an equivalent combination of industrial uses generating no more than 305 p.m. peak hour trips. This policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(c).
- D) CPA09-002 ICI Villages LLC (Ordinance 2009-20): Approximately 487.19 acres lying in Sections 29, 30 and 31, Township 2S, Range 23 East located between U.S. Route 90 and Interstate 10. This property was the subject of CPA09-002 (Ordinance 2009-20) and is owned by ICI Villages LLC of Daytona Beach, Florida. Conservation easements shall be established pursuant to Sec. 704.06 F.S. in order to preserve and maintain a minimum of seventy five (75) acres south of the CSX rail line and shall be classified as Conservation I. The easements shall be established prior to the first site plan approval on the industrial site. The limits of this

conservation area are subject to minor refinement to reflect a more exacting description when the property has been issued an Environmental Resource Permit by the St. Johns River Water Management District. Development of the Subject property shall be limited to 2,350,000 square feet of uses permitted in the Industrial portion and 40,000 enclosed square feet of uses permitted in the Commercial portion that altogether generate no more than 688 external p.m. peak hour trips. Any development of the property that would generate more than 688 peak hour trips must be preceded by an amendment to the Schedule of Capital Improvements including any roadway improvements needed to achieve and maintain the adopted level of service based upon the maximum development potential. The Capital Improvements contained in the Comprehensive Plan Amendment shall be derived from a traffic impact study whose methodology is acceptable to the City of Jacksonville Planning and Development Department, Nassau County Growth Management Department, and the Florida Department of Transportation. This policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(e).


CPA10-001 Terra Pointe, LLC (Ordinance 2010-06): Approximately 1,814 acres lying in Sections 2, 3, 4, 9, 10 and 11, Township 1 North, Range 24 East located near the intersection of U.S. Highway 301 and Crawford Road. This property was the subject of CPA10-001 and is owned by Terra Pointe, LLC of Fernandina Beach. A minimum of 309 acres of wetlands shall be preserved within the site. Development of the remaining portions of the property shall be limited to 780,000 sq. ft. of General Light Industrial (ITE 110), 780,000 sq. ft. of Manufacturing (ITE 140), and 3,640,000 sq. ft. of High Cube Warehouse (ITE 152) or any equivalent use(s) permitted by the industrial FLUM category generating no more than 1,942 p.m. peak hour trips. If at any time of development either:

- i) Link 83 (CR119 to Crawford Rd and Link 84 (Crawford Road to Pickett Road) on US Highway 301 are widened to 4 lanes; or
- ii) Links 83 and 84 are in FDOT's Five-Year Work Program; or

iii) Links 83 and 84 are moved into the County's adopted Capital Improvements Schedule; then development consistent with the Industrial FLUM category that generates up to 2,507 additional external pm peak hour trips shall be allowed for the subject property (4,449 total trips). No commercial mining operations shall be permitted within the property. This policy shall succeed 2010 Comprehensive Plan Policy 1.09.08(f).

## Map 1: Nassau County CPA24-001 Location Map


#### LOCATION MAP 248.75ac FLUM Amendment 301 CAPITAL PARTNERS, LLC.

- 2. Civic Spark Fellow for Affordable Housing/Resiliency Project accepted by the program, hiring process to take place over next several months.
  - ▶ Match requirement is \$29,000 for 10-month work program



COORDINATOR (CTC)

The Northeast Florida Regional Council (NEFRC) is designated as the Designated Official Planning Agency (DOPA) for the Transportation Disadvantaged Program for Nassau County. Florida Statutes, Sec. 427.015, states that each DOPA shall recommend to the Commission for the Transportation Disadvantaged (Commission) a single community transportation coordinator. Florida Administrative Code, P. 41-2.010, states that the selection of the Community Transportation Coordinator (CTC) will be accomplished through public competitive bidding or proposals in accordance with applicable laws and rules.

The Nassau County Council on Aging notified the Commission for the Transportation Disadvantaged on December 4, 2023, that they would be stepping down as the CTC effective September 30, 2024. As a result, the NEFRC initiated a Request for Proposals (RFP) process for selecting a new CTC to serve Nassau County beginning on October 1, 2024.

To initiate the public competitive bidding process, a Request for Proposals (RFP) for the provision of service in Nassau County was published in the Florida Administrative Register and posted to the NEFRC website on January 22, 2024. One response to the RFP was received from the Jacksonville Transportation Authority.

After carefully considering all aspects of the RFP process, the evaluation committee believes the Jacksonville Transportation Authority is capable of providing cost-effective, quality transportation disadvantaged service to Nassau County.

The Nassau County LCB recommendation now comes before the NEFRC Executive Committee, as the DOPA, for their review and recommendation. The Nassau County LCB and the NEFRC recommendation will be carried forward to the Commission for the Transportation Disadvantaged at an upcoming meeting.

### **Recommendation:**

The NEFRC, as the Designated Official Planning Agency for the Transportation Disadvantaged Program, recommends to the Commission for the Transportation Disadvantaged that Jacksonville Transportation Authority be Nassau County's Community Transportation Coordinator.
