### 2025 Legislative Priorities Discussion

Ms. Payne shared with the Members the process utilized to obtain and identify the regional priorities. This process includes the solicitation for Regional Priorities was distributed to from our seven counties that are due in November, a review by the Committee of the priorities received, and selection of those with the most regional significance for consideration as a top priority of the Region. She also shared the proposed timeline for the compilation of Regional Priorities with a goal of presenting the printed document at our January 9, 2025 Board meeting.

The Committee discussed the layout and design of the final document and, by consensus, agreed to replicate the format used for the 2024 Priorities – a two-sided flyer and a palm card.

It was determined that this Committee will meet again on December 5<sup>th</sup>, prior to the Executive Committee, to review the draft document, select the Regional Priorities, and approve the design option for consideration by the Executive Committee.
